*L3000 is billed as 2 separate line items, right and left. If the patient's insurance benefits do not cover the custom foot orthotics, it is suggested to charge your normal cash fee for foot orthotics. Medicare will not pay for foot orthotics with the Richie AeroSpring Bracing System. The provider can also pass along additional charges for heel wedges as a cash charge to the patient.

- Medicare authorization is not needed. Supplemental insurance may require preauthorization (but it typically pays the co-pay if Medicare approves.)
- Add a KX modifier to all L codes for billing.
